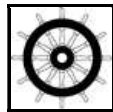

## **Product description**

"Renotech Renolmage"

Is a waterbased adhesive, paint/ink and surface lacquer.

Density: 1.1 kg /dm<sup>3</sup>.

Thickness: 80-120 µm.

## **Application/Limitation**

Low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use on non-combustible substrate with density of at least 1200 kg/m<sup>3</sup> and on metallic substrate with thickness of at least 2.25 mm.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (ref. SOLAS Chapter II-2 Reg. 5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation, use and maintenance.

## **Tests carried out**
